ORDER

This matter arises upon the consolidation of Kentucky Utilities Company (KU) and Louisville Gas and Electric Company's (LG&E) (jointly, LG&E/KU) Case No. 2023-00122<sup>1</sup> into this proceeding. On May 16, 2023, the Commission granted LG&E/KU's motion requesting to consolidate the two cases, which involve similar questions of law and fact.

Because Case No. 2023-00122 was filed approximately four months after the application in this proceeding was deemed filed, the Commission, on its own motion, finds that the procedural schedule established on January 6, 2023, should be amended to provide the Commission and the parties with the opportunity to develop a robust case record for all issues presented in this proceeding. The amended procedural schedule is attached as an Appendix to this Order.

Additionally, the August 22–25, 2023 hearing scheduled in this matter shall be held on the designated day or days and continued until called from the bench by the presiding

officer. Pursuant to 807 KAR 5:001E, Section 2, if the hearing is not concluded on the designated day, the hearing may be continued upon verbal announcement by the presiding officer. A verbal announcement made by the presiding officer shall be proper notice of the continued hearing. Hearings are held in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky. Witnesses who sponsor schedules, testimony, or responses to requests for information are expected to participate in person at a hearing.

Finally, the Commission finds that the case style of this proceeding should be amended to reflect the subject matter of this proceeding and Case No. 2023-00122.

IT IS THEREFORE ORDERED that:

1. The procedural schedule established in the January 6, 2023 Order is stricken and replaced with the amended procedural schedule set forth in the Appendix to this Order.

2. All other provisions of the January 6, 2023 Order not in conflict with this Order shall remain in effect.

3. The case style is amended and parties to this proceeding shall use the following case style on each subsequent filing in this case: "ELECTRONIC JOINT APPLICATION OF KENTUCKY UTILITIES COMPANY AND LOUISVILLE GAS AND ELECTRIC COMPANY FOR CERTIFICATES OF PUBLIC CONVENIENCE AND NECESSITY AND SITE COMPATIBILITY CERTIFICATES AND APPROVAL OF A DEMAND SIDE MANAGEMENT PLAN AND APPROVAL OF FOSSIL FUEL-FIRED GENERATING UNIT RETIREMENTS."
