ORDER

On February 24, 2023, Amanda Hill, counsel for Cumberland Falls Highway Water District (Cumberland Falls Highway District), filed a motion to continue the hearing date set for March 30, 2023.<sup>1</sup> As grounds for the motion, counsel will be in Spain on the date set for the hearing as that week is the Corbin Independent School system Spring Break. Also, counsel noted that Jeffrey Sparks is also scheduled to be out of town on that date.

The Commission finds that travel out of the country is good cause to reschedule the hearing. The Commission will set the new date for April 20, 2023, as the rescheduled hearing date. The Commission expects to hear testimony from the Chairman of the Board of Commissioners, Johnny Collette; district employee, Malea Moses; district manager, Michael Baird; and the contractor requesting reimbursement, Jeffrey Sparks.

The Commission HEREBY ORDERS that:

1. Cumberland Falls Highway District's motion for a continuance of the hearing date is granted.
2. A hearing in this matter shall be held on April 20, 2023, at 9 a.m. Eastern Daylight Time and continuing until called from the bench by the presiding officer, in the

Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.

3. Pursuant to 807 KAR 5:001E, Section 2, if the hearing is not concluded on the designated day, the hearing may be continued upon verbal announcement by the presiding officer. A verbal announcement made by the presiding officer shall be proper notice of the continued hearing.

4. Witnesses who sponsor schedules, testimony, or responses to requests for information shall participate in person at the hearing.

5. The Commission shall issue subpoenas for Johnny Collette, 6926 Cumberland Falls Highway, Corbin, Kentucky 40701-8637; Malea Moses, 6926 Cumberland Falls Highway, Corbin, Kentucky 40701-8637; Michael Baird, 6926 Cumberland Falls Highway, Corbin, Kentucky 40701-8637; and Jeffrey Sparks, 212 Diamond Lane, Corbin, Kentucky 40701.

6. The Executive Director will provide a copy of this Order to the Whitley County Judge Executive, PO Box 237, Williamsburg, Kentucky 40769.

7. Cumberland Falls Highway District shall give notice of the hearing in compliance with 807 KAR 5:001E, Section 9(2)(b). In addition, the notice of hearing shall include the following statements: "This hearing will be streamed live and may be viewed on the PSC website, [psc.ky.gov](http://psc.ky.gov)"; and "Public comments may be made at the beginning of the hearing. Those wishing to make oral public comments may do so by following the instructions listed on the PSC website, [psc.ky.gov](http://psc.ky.gov)." At the time the notice is mailed or publication is requested, Cumberland Falls Highway District shall forward a duplicate of the notice and request to the Commission.

8. Pursuant to KRS 278.360 and 807 KAR 5:001E, Section 9(9), a digital video transcript shall be made of the hearing.



