ORDER

On February 2, 2024, Kentucky Power Company (Kentucky Power) moved the Commission to admit *pro hac vice* Hector Garcia Santana, an attorney whose office is in Columbus, Ohio, to practice law before the Commission on behalf of Kentucky Power and in association with Katie M. Glass, an attorney licensed to practice law in the Commonwealth of Kentucky, in this case.<sup>1</sup> In support of the request, Hector Garcia Santana has shown that he is a member in good standing of another state bar and has been certified to practice before the Commission in this case by the Kentucky Bar Association under Kentucky Supreme Court Rule 3.030(2). In addition, Hector Garcia Santana has agreed to be subject to the jurisdiction and rules of the Commission and the Kentucky Bar Association.

IT IS THEREFORE ORDERED that Hector Garcia Santana is admitted *pro hac vice* for the purpose of representing Kentucky Power in association with Katie M. Glass in the above-styled proceeding, provided that Katie M. Glass, or another member of the
