ORDER

On February 15, 2023, South 641 Water District (South 641 District) filed an application with the Commission, pursuant to 807 KAR 5:076, requesting to adjust its sewer rates.¹ A procedural schedule was issued on March 9, 2023, requiring Commission Staff to file with the Commission and serve upon all parties of record a written report (Commission Staff's Report) containing its findings and recommendations regarding South 641 District's requested sewer rate adjustment, no later than July 11, 2023.

Due to numerous Commission Staff scheduling conflicts, the Commission, on its own motion, finds that the procedural schedule established on March 9, 2023, should be amended to afford Commission Staff additional time to prepare and file the Commission Staff's Report. Specifically, the Commission finds that the date for filing the Commission Staff's Report should be extended to July 27, 2023.

After Commission Staff's Report is filed on or before the amended deadline of July 27, 2023, South 641 District will have 14 days to file a written response to

¹ Pursuant to 807 KAR 5:076, Section 7(2), if the Commission has not issued an order after six months from the date an alternative rate filing application is deemed filed, the utility may place the proposed rates into effect, subject to refund, pending the Commission's order upon filing written notice with the Commission of its intent to do so. Otherwise, an applicant using the alternative rate filing procedure may not place the proposed rates into effect until the Commission has issued an order approving the rates. 807 KAR 5:076, Section 7(1).

Commission Staff's Report.² If South 641 District does not file written objections to a finding contained in Commission Staff's Report within 14 days after the date of the filing of Commission Staff's Report, it shall be deemed a waiver of all objections to that finding.³

IT IS THEREFORE ORDERED that:

1. The procedural schedule established on March 9, 2023, is amended.
2. Commission Staff's Report shall be filed no later than July 27, 2023.
3. South 641 District shall file its written response, if any, to Commission Staff's Report within 14 days of the filing of the report.
4. All provisions of the Commission's Order of March 9, 2023, in conflict with the provisions of this Order are vacated. All other provisions of the Commission's Order of March 9, 2023, shall remain in effect.


