ORDER

On July 21, 2023, Kentucky Power Company (Kentucky Power) filed a motion requesting to amend the procedural schedule issued by the Commission on April 14, 2023.¹ Kentucky Power stated it is a party in multiple other cases at the Commission that all have similar procedural dates for responses to requests for information and testimony.² Kentucky Power stated that many of the witnesses responsible for responding to requests for information in this proceeding are also responsible for responding to requests for information and providing testimony in other cases.³ Kentucky Power stated that the extension of the procedural schedule in this case will not prejudice the Commission or any of the intervening parties.

The Commission finds that Kentucky Power's motion should be granted and the procedural schedule established in the Commission's April 14, 2023 Order should be amended. The amended procedural schedule is attached as an Appendix to this Order. The Commission finds that Kentucky Power, and any intervenors, should respond to all

requests for information propounded by Commission Staff in this case according to the date set forth on those requests, regardless of whether they appear on this amended schedule.

IT IS THEREFORE ORDERED that:

- 1. Kentucky Power's motion to amend the procedural schedule in this case is granted.
- 2. The amended procedural schedule set forth in the Appendix to this Order shall be followed.
- 3. Kentucky Power and intervenors shall respond to all requests for information propounded by Commission Staff, whether identified in the procedural schedule or otherwise, as provided by those requests.
- 4. All provisions of the Commission's Order of April 14, 2023, that are in conflict with the provisions of this Order are vacated. All other provisions of the Commission's April 14, 2023 Order not in conflict shall remain in effect.
