During the summer I months I have to choose to feed my children and not run the AC accept for one or two hours at night before bed so the electric bill isn't so outrageous. With AC running set at 70 all day in a two bed one bath apartment with no washer/dryer hookup will run me nearly \$145 to \$185 a month yet on Big Sandy Recc just a mile down the road where I used to live for a 3 Bed 2 bath running AC all day with washer/dryer hookup and a dish washer will run \$110 to \$125. Then on top of Kentucky Power's Price gouging they sometimes charge you double for using less electricity, like if you used less electric compared to the previous month your bill is higher and the company blames it fuel cost or some other poor excuse. During the winter time I have no choice, but to run heat and with the increase cost of food and shelter Ky Powers price increases aren't helping a single parent income home!
