## ORDER

On April 5, 2023,<sup>1</sup> the Henderson County Water District (Henderson District) filed its application with the Commission requesting an adjustment to its water rates pursuant to 807 KAR 5:076. Henderson District filed this proceeding in compliance with the final Order in Case No. 2023-00041.<sup>2</sup> In that proceeding, Henderson District was ordered to file an application for a traditional adjustment in rates or an alternative rate filing (ARF) as soon as possible.

The Commission finds that a procedural schedule<sup>3</sup> should be established to ensure the orderly review of Henderson District's application. The procedural schedule is attached as Appendix A to this Order.

<sup>&</sup>lt;sup>3</sup> No action is necessary to suspend the effective date of Henderson District's proposed rates for service. Pursuant to 807 KAR 5:076, Section 7(1), an applicant who applies for a rate adjustment pursuant to the procedures set for in 807 KAR 5:076 may not place its proposed rates into effect until the Commission approves those rates or six months from the date of the filing of its application.

In addition, Henderson District shall file on or before the date set forth in the procedural schedule its responses to the Commission Staff's First Request for Information, attached to this Order as Appendix B, and shall respond to any future requests for information propounded by Commission Staff by the date or dates set forth on any such requests.

### IT IS THEREFORE ORDERED that:

- 1. The procedural schedule set forth in Appendix A to this Order shall be followed.
- 2. On or before the date set forth in the procedural schedule, Henderson District shall file its responses to the Commission Staff's First Request for Information, attached to this Order as Appendix B.
- 3. Henderson District shall respond to any additional requests for information propounded by Commission Staff as provided in those requests.
- 4. No later than the date set forth in the procedural schedule, Commission Staff shall file with the Commission and serve upon all parties of record a written report (Commission Staff's Report) containing its findings and recommendations regarding Henderson District's requested rate adjustment.
- 5. No later than 14 days after the date of service of the Commission Staff's Report, each party of record shall file with the Commission:
- a. Its written comments on and any objections to the findings contained in the Commission Staff's Report; and
  - b. Any additional evidence for the Commission to consider.

- 6. If Commission Staff recommends that Henderson District's financial condition supports a higher rate than Henderson District proposes or the assessment of an additional rate or charge not proposed in Henderson District's application, Henderson District in its response to the Commission Staff's Report shall also state its position in writing on whether the Commission should authorize the assessment of the higher rate or the additional rate or charge.
- 7. If Commission Staff recommends that changes should be made to the manner in which Henderson District accounts for the depreciation of Henderson District's assets, Henderson District in its response to the Commission Staff's Report shall also state its position in writing on whether the Commission should require Henderson District to implement the proposed change for accounting purposes.
- 8. A party's failure to file written objections to a recommendation contained in the Commission Staff's Report within 14 days after the date of the filing of the Commission Staff's Report shall be deemed a waiver of all objections to that finding.
- 9. If a party requests a hearing or informal conference, then the party shall make the request in its written comments and state the reason a hearing or informal conference is necessary.
- 10. A party's failure to request a hearing or informal conference in the party's written response shall be deemed a waiver of all rights to a hearing on the application and a request that the case stand submitted for decision.
- 11. A party's failure to file a written response within 14 days after the date of service of the Commission Staff's Report shall be deemed a waiver of all rights to a hearing on the application.

- 12. As set forth in 807 KAR 5:001E, Section 4(11)(a), a person requesting permissive intervention in a Commission proceeding is required to demonstrate either (1) a special interest in the proceeding that is not adequately represented in the case, or (2) that the person requesting permissive intervention is likely to present issues or develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. Therefore, any person requesting to intervene in a Commission proceeding must state with specificity the person's special interest that is not otherwise adequately represented or the issues and facts the person will present that will assist the Commission in fully considering the matter. A mere recitation of the quantity of water consumed by the movant or a general statement regarding a potential impact of possible modification of rates will not be deemed sufficient to establish a special interest.
- 13. Any motion to intervene filed after the date established in the procedural schedule attached as an Appendix to this Order shall also show good cause for being untimely. If the untimely motion is granted, the movant shall accept and abide by the existing procedural schedule.
- 14. The Commission directs the parties to the Commission's July 22, 2021 Order in Case No. 2020-00085<sup>4</sup> regarding filings with the Commission.

## COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION TO HENDERSON COUNTY WATER DISTRICT

Henderson County Water District (Henderson District), pursuant to 807 KAR 5:001E, shall file with the Commission an electronic version of the following information. The information requested is due on June 5, 2023. The Commission directs Henderson District to the Commission's July 22, 2021, Order in Case No. 2020-00085<sup>1</sup> regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Henderson District shall make timely amendment to any prior response if Henderson District obtains information that indicates the response was incorrect or

incomplete when made or, though correct or complete when made, is now incorrect or incomplete in any material respect.

For any request to which Henderson District fails or refuses to furnish all or part of the requested information, Henderson District shall provide a written explanation of the specific grounds for its failure to respond completely and precisely.

Careful attention shall be given to copied and scanned material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Henderson District shall, in accordance with 807 KAR 5:001E, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

- 1. Provide the number of occurrences and the dollar amount for Forfeited Discounts/Late Fees that were assessed during the calendar years 2021 and 2022.
- 2. Provide the total amount recorded for each nonrecurring charge and the number of occurrences for each nonrecurring charge that was assessed during the 2021 test year and calendar year of 2022.
- 3. Provide an updated cost justification sheet for each nonrecurring charge listed in Henderson District's tariff.
- 4. Provide an updated cost justification sheet for each Meter Connection/Tapon Fee listed in Henderson District's tariff.

- 5. a. Provide the date that Henderson District billing cycle begins (meter read date).

- 10. Provide a copy of the certificates of insurance and invoices for General Liability, Workers' Compensation, Automobile, and Property and Casualty for 2021, 2022, and 2023.
- 11. Provide a description of all employee benefits, other than salaries and wages, paid to, or on behalf of, each employee for the calendar years 2021 and 2022, and the year to date for 2023.
- 12. Provide a copy of the most recent invoice for 2023 for each employee benefit described above.
- 13. Provide a document listing the names and terms, including term beginning and end dates, for all Henderson District's Board members for each calendar year 2020, 2021, 2022, and 2023.
  - 14. Provide the annual compensation for each current board member.
- 15. Provide Fiscal Court minutes that authorize the appointment and specify salaries of Board members.
  - 16. Provide training records for each Board member for 2020, 2021, and 2022.
  - 17. Provide the total number of utility employees, broken out by position.

in the Annual Report 352,245,000 gallons and the Total Gallons Sold reported in Billing Analysis 334,729,760 gallons.
