ORDER

Union County Water District (Union District) filed a motion on July 6, 2023, requesting the Commission to accept its responses to Commission Staff's First Request for Information (Staff's First Request) filed after the Commission's deadline. Pursuant to the procedural schedule issued by Order on May 22, 2023, Union District's responses to these requests were due on July 3, 2023.¹

Union District filed its responses to Staff's First Request simultaneously with its motion on July 6, 2023. In the motion, Union District's counsel stated that Union District did provide narrative responses and documentation to counsel in advance of the deadline, yet counsel inadvertently failed to file the responses prior to the deadline. Union District requested the responses be accepted as filed, three days past the deadline. The motion further stated the district has no objection to an extension of subsequent deadlines.

The Commission, having considered Union District's motion, finds that, given counsel's inadvertent delay in filing its responses and Union District's efforts to respond to those requests to date, good cause exists to accept the responses to Staff's First Request filed on July 6, 2023. The Commission accordingly finds it is necessary to amend the procedural schedule contained in the Appendix to the May 22, 2023 Order, to allow adequate time for all parties to process further requests for information.

IT IS THEREFORE ORDERED that:

- 1. Union District July 6, 2023 motion is granted.
- The procedural schedule contained in the Commission's Order of May 22,
 s amended as attached in the Appendix to this Order.
- 3. All provisions of the Commission's Order of May 22, 2023, in conflict with the provisions of this Order are vacated. All other provisions of the Order of May 22, 2023, shall remain in effect.
