RE: Informal Conference of August 21, 2023

Pursuant to Staff Notice issued on August 4, 2023, an informal conference (IC) was conducted on August 21, 2023. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss issues pertaining to Reid Village Water District's filing for a Rate Adjustment Pursuant to 807 KAR 5:076, particularly responses to a request for information relating to its billing analysis. On August 20, 2023, Robert Miller emailed Commission Staff and provided supplemental information prior to the scheduled IC. Staff reviewed this information and found that it helped clarify questions staff had regarding the billing analysis. Additional questions regarding rates after a purchase water adjustment (PWA) in 2022 arose as well as ways to ensure future billing analysis reports were more usable. Mr. Miller agreed to make an adjustment to the current information provided to include a separate section for the 2022 PWA rates as well as to work with Reid Village Water District to contact their software vendor and discuss addressing ways to avoid future errors in their reports. Mr. Miller also agreed to file the information that he emailed Commission Staff, after making the discussed adjustment, into the record as supplemental responses.

There being no further discussion, the IC was then adjourned.
