ORDER

On July 12, 2023, the city of Louisa (Louisa) moved the Commission to dismiss the above-styled case, Case No. 2023-00146, without prejudice.

On May 2, 2023, the Commission established this proceeding to investigate the reasonableness of Louisa’s proposed wholesale rate increase to Big Sandy Water District and entered an Order establishing a procedural schedule.<sup>1</sup> Commission Staff issued its First Request for Information (Staff’s First Request) on May 17, 2023. Responses to Staff’s First Request were due on June 1, 2023. On June 5, 2023, the Commission granted Louisa’s May 26, 2023 motion for an extension of time to respond to Staff’s First Request. On June 9, 2023, Louisa filed another motion for an extension of time to respond to Staff’s First Request. On June 23, 2023, the Commission granted Louisa another extension until June 30, 2023. An informal conference was held on June 27, 2023, for the purpose of discussing the case. On June 27, 2023, Louisa filed a third motion for an extension of time to respond to Staff’s First Request until July 31, 2023. Louisa has not filed any responses to Staff’s First Request.

Based on the motion and being otherwise sufficiently advised, the Commission finds that good cause exists to dismiss the case without prejudice with leave to refile due to the multiple requests for extensions. The Commission further finds that Louisa's third motion for an extension of time is moot and should be denied.

IT IS THEREFORE ORDERED that:

1. Louisa's motion to dismiss without prejudice with leave to refile Case No. 2023-00146 is granted.
2. Louisa's third motion for an extension of time is denied as moot.
3. This case is closed and removed from the Commission's docket.
