ORDER

On January 11, 2024, the Commission issued an Order¹ approving an increase in Harrison County Water Association, Inc.'s (Harrison Water) rates for retail water service. Appendix B of the Order incorrectly set the 3/4-inch Meter Minimum Bill rate at \$34.38 due to a typographical error when the correct calculated rate for the 3/4-inch Meter Minimum Bill should have been stated as \$28.48.

Additionally, an error was found in the 2-inch Meter Minimum Bill in Appendix B of the Order. The rate utilized in the calculation for the 2-inch Meter Minimum Bill was incorrectly applied from Exhibit 1 of the application instead of from the tariff rate on file with the Commission. The rate in Exhibit 1 of the application for the 2-inch Meter Minimum Bill rate was stated as \$103.99, and the correct 2-inch Meter Minimum Bill rate, as stated in the tariff on file with the Commission, was \$116.29. Therefore, the \$110.04 rate that was in Appendix B of the Order was incorrectly stated.

Once these rates were updated to the correct rates of \$28.48 for the 3/4-inch Meter Minimum Bill and \$116.29 for the 2-inch Meter Minimum Bill and the percentage increase

of 5.82 was applied, the correct 2-inch Meter Minimum Bill is \$123.06 and the correct 3/4-inch Meter Minimum Bill is \$30.48.

Finding that the rates approved in the January 11, 2024 Order should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. The rate Appendix B to the January 11, 2024 Order is stricken and replaced with the Appendix to this Order.

2. The adjusted rates in the Appendix to this Order are fair, just and reasonable.

3. All other provisions of the Commission's January 11, 2024 Order that are not in conflict with the terms of this Order shall remain in effect.

4. Within 20 days of the date of service of this Order, Harrison Water shall file with the Commission revised tariff sheets containing the approved rates.

5. Harrison Water shall collect any under collection or issue any refund, over a period of two months, for any difference between the rates for retail water service placed into effect following the January 11, 2024 Order, and the rates provided in the Appendix to this Order.

6. Within 20 days of the date of this Order, Harrison Water shall file in this case a statement detailing the amounts billed to its retail customers in excess of the rates authorized in this Order with totals for each type of charge separately stated.
