## ORDER

On July 6, 2023, North Manchester Water Association, Inc. (North Manchester Water), filed an application with the Commission, pursuant to 807 KAR 5:076, requesting an adjustment to its water rates.<sup>1</sup> The Commission established an initial procedural schedule that was subsequently amended after North Manchester Water requested an extension of time to respond to the Commission Staff's First Request for Information (Staff's First Request).<sup>2</sup>

Commission Staff scheduled an Informal Conference for October 3, 2023.<sup>3</sup> Based upon the information that has been filed into the record of this case so far, the Commission now finds that a Field Review will be necessary. Therefore, the Commission, on its own motion, finds it is necessary to amend the procedural schedule.
