**RE:** Informal Conference of April 9, 2025

Pursuant to a Staff Notice issued on March 24, 2025, an informal conference (IC) was conducted on April 9, 2025. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss McKinney Water District's (McKinney District) motion for approval to use surcharge funds filed on March 12, 2025, and numerous invoices filed into the record from Scott Coffman Excavating and Consolidated Pipe & Supply Company, Inc. Staff requested that McKinney District provide further explanation as to the repairs or work performed for each invoice, the correlation with water loss reduction efforts, and any connection to the projects proposed in the qualified infrastructure improvement plan. Staff also cautioned that any further request for approval to use water loss surcharge funds for costs that have already been expended should include the detailed description referenced above, and that the request should be for reimbursement of those costs.

There being no further discussion, the IC was then adjourned.
