**RE:** Informal Conference of December 1, 2025

Pursuant to a Staff Notice issued on November 24, 2025, an informal conference was conducted on December 1, 2025. Attached is a copy of the attendance roster.

The purpose of the informal conference was to discuss McKinney Water District's request for reimbursement filed March 12, 2025, 2024, invoices filed on January 23, 2025, and March 5, 2025, as well as Commission Staff's Third Request for Information (Staff's Third Request) filed on November 24, 2025. Staff revisited the discussion from the prior informal conference on April 9, 2025 with McKinney Water District regarding the information that is needed to provide the Commission in order to reach a decision regarding McKinney District's request for reimbursement from the surcharge funds. Staff discussed the information sought from Staff's Third Request, and confirmed that McKinney District was aware of the filing deadline and did not have any questions regarding those requests. McKinney District stated that it had been compiling the information sought from Staff and it would be providing the information in the near future.
