ORDER

On June 16, 2023, Lindsey & Elliott Gas Co. (Lindsey & Elliott Gas) filed, through the Commission’s electronic Tariff Filing System, its tariff to establish initial rates, rules, and regulations pursuant to KRS 278.445 and 807 KAR 5:026. On July 7, 2023, the tariff filing was suspended pursuant to KRS 278.190(2) for five months pending an investigation to determine the reasonableness of the proposed tariff.¹ As a result of Lindsey & Elliott Gas’ response to Commission Staff’s Second Request for Information (Staff’s Second Request), in which Lindsey & Elliott Gas responded that some rules and regulations were inadvertently omitted from Lindsey & Elliott Gas’ proposed tariff,² on January 22, 2024, the Commission issued an Order granting Lindsey & Elliott Gas leave to amend its tariff and deemed the tariff filed as of September 29, 2023.³ Subsequent to the Order granting Lindsey & Elliott Gas leave to amend its tariff, Commission Staff issued its Third Request for Information (Staff’s Third Request) on March 27, 2024, directing

Lindsey & Elliott Gas to respond on or before April 19, 2024.⁴ On April 4, 2024, Lindsey & Elliott Gas filed a motion requesting an extension of time to respond to Staff's Third Request on or before May 24, 2024.⁵

In its motion, Lindsey & Elliott Gas stated that due to the short turnaround during Spring Break and a death of a family member involving Lindsey & Elliott Gas' principal, Lindsey & Elliott Gas requested additional time to complete its responses, and therefore, moved the Commission for an extension of time no later than May 24, 2024, to file its responses to Staff's Third Request.

The Commission, having considered Lindsey & Elliott Gas' motion, finds that good cause exists to grant an extension of time to no later than May 24, 2024, to file its responses to Staff's Third Request.

IT IS THEREFORE ORDERED that:

1. Lindsey & Elliott Gas' motion for an extension of time is granted.
2. Lindsey & Elliott Gas shall file its response to Staff's Third Request no later than May 24, 2024.
3. The Commission does not look favorably upon motions for continuance. Accordingly, future motions for extensions of time shall be made in writing and will be granted only upon a showing of good cause.
