ORDER

On June 18, 2024, the Commission issued an Order in this matter setting rates in Oldham County Water District (Oldham District) in an alternative rate filing adjustment to its water service rates pursuant to 807 KAR 5:076. Subsequently, the Commission has identified three errors in the Order. First, the Order includes a meter test fee in Appendix A and B that is rounded down to \$19.00 rather than to the nearest dollar amount, which is \$20.00. Additionally, the Order failed to distinguish between the rates associated with "connection turn on" and "connection turn on" listed in Appendix B, the latter should have been designated as "connection turn on (after hours)". Finally, the Order omitted the tap on fee of \$2,200 from Appendix B.

Finding that the June 18, 2024 Order should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:
