ORDER

On October 2, 2023, Kenergy Corp. (Kenergy) filed its application for an increase of rates based on a historical test year pursuant to KRS 278.180 and KRS 278.190. The Commission established a procedural schedule by Order dated October 12, 2023, that sets out dates for timely and orderly processing of the case. This schedule was amended on January 16, 2024, to establish a deadline by which the utility or any intervenor may request a hearing or that the case be submitted for decision based on the record, as well as extending the time for supplemental requests for information to Kenergy.

On February 14, 2024, Kenergy and the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General) jointly filed a motion waiving a hearing in this case, requesting that the case be decided upon the written record, and asking for an opportunity to submit briefs on the matter to the Commission.¹

Having reviewed the request of both Kenergy and the Attorney General, the Commission finds that good cause has been established to amend the procedural

schedule to allow for a briefing schedule and that the parties' requests to file written briefs on the matter should be granted. This will allow both parties to highlight their arguments and different positions.

IT IS THEREFORE ORDERED that:

1. The procedural schedule established on January 16, 2024, is amended.
2. Kenergy and the Attorney General's joint motion to file written briefs on the matter is granted.
3. All parties that choose to do so may file a brief in support of their respective positions on or before March 6, 2024.
4. All parties that choose to do so may file a reply brief, responding to issues raised in other parties' respective briefs, on or before March 13, 2024.
5. This case shall stand submitted for a decision by the Commission effective 12:01 a.m. Eastern Daylight Time on March 14, 2024.
