ORDER

On February 5, 2024, Kentuckians for the Commonwealth and Kentucky Resources Council (collectively, Joint Intervenors) moved the Commission to admit *pro hac vice* Thomas Cmar, an attorney whose office is in Ohio; Mychal Ozaeta, an attorney whose office is in California; and Shannon Fisk, an attorney whose office is in New York, to practice law before the Commission on behalf of Joint Intervenors in association with Tom FitzGerald, Ashley Wilmes, and Bryon Gary, attorneys licensed to practice law in the Commonwealth of Kentucky, in this case. IT IS THEREFORE ORDERED that Thomas Cmar, Mychal Ozaeta, and Shannon Fisk are admitted *pro hac vice* for the purpose of representing Joint Intervenors in association with Tom FitzGerald, Ashley Wilmes, and Bryon Gary, in the above-styled proceeding, provided that Tom FitzGerald, Ashley Wilmes, and Bryon Gary, or another

member of the Kentucky Bar Association acts as co-counsel and is present at all proceedings before this Commission.
