ORDER

On December 2, 2024, Mountain Water District (Mountain District) filed an amended Qualified Infrastructure Improvement Plan (QIIP), which included a request for authorization use water loss surcharge funds.<sup>1</sup> On February 21, 2025, the Commission entered an Order which partially granted the request and issued Commission Staff's Second Request for Information (Staff's Second Request) with a response due on March 14, 2025. On March 2, 2025, Mountain District filed a motion for extension of time for the request for information.<sup>2</sup>

Mountain District stated that as a result of recent flooding the staff who would ordinarily prepare the response were occupied with service restoration and damage assessment. Mountain District stated it was requesting an extension until April 11, 2025.<sup>3</sup>

The Commission finds that Mountain District's request for an extension should be granted. The Commission finds that good cause exists to grant the extension as a result

IT IS THEREFORE ORDERED that:


1. Mountain District's request for an extension to respond to Staff's Second Request until April 11, 2025, is granted.

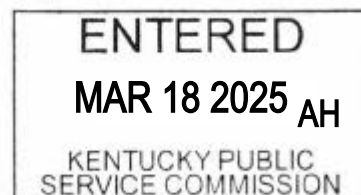
