ORDER

On December 22, 2023, Duke Energy Kentucky, Inc.'s (Duke Kentucky) filed a motion to amend the Commission's December 21, 2023 final Order issued in this proceeding that approved Duke Kentucky's Demand-Side Management (DSM) rates for electric and gas service.

As a basis for the motion, Duke Kentucky explained that the Appendix to the Order listed the incorrect rate for the electric Non-Residential Distribution class. Duke Kentucky further explained that the value in the Appendix was inadvertently misstated and that the rate listed was \$0.002989 per kWh when it should be \$0.003503 per kWh.

Based upon a review of the motion and the December 21, 2023 Order, the Commission finds that the December 21, 2023 Order inadvertently misstated the Non-Residential Distribution class rate, which was approved by the Commission. For that reason, the Commission finds that Duke Kentucky's motion should be granted.

The Commission further finds that the rates set forth in the Appendix to this Order should be effective as of the first billing cycle of the month following the December 21, 2023 Order.

IT IS THEREFORE ORDERED that:

1. Duke Kentucky's motion to amend the December 21, 2023 Order is granted.
2. The Appendix attached to the December 21, 2023 Order is stricken and replaced with the Appendix attached to this Order.
3. The rates set forth in the Appendix to this Order are effective as of the first billing cycle of the month following the December 21, 2023 Order.
4. All other provisions of the December 21, 2023 Order shall remain in effect.
