ORDER

On December 6, 2023,¹ Peaks Mill Water District (Peaks Mill District) filed its application with the Commission requesting an adjustment to its water rates pursuant to 807 KAR 5:076.

The Commission finds that a procedural schedule² should be established to ensure the orderly review of Peaks Mill District's application. The procedural schedule is attached as Appendix A to this Order.

In addition, Peaks Mill District shall file on or before the date set forth in the procedural schedule its responses to the Commission Staff's request for information, attached to this Order as Appendix B, and shall respond to any future requests for information propounded by Commission Staff by the date or dates set forth on any such requests.

¹ Peaks Mill District tendered its application on December 4, 2023. By letter dated December 6, 2023, the Commission rejected the application for filing deficiencies. The deficiencies were subsequently cured, and the application is deemed filed on December 6, 2023.

² No action is necessary to suspend the effective date of Peaks Mill District's proposed rates for service. Pursuant to 807 KAR 5:076, Section 7(1), an applicant who applies for a rate adjustment pursuant to the procedures set for in 807 KAR 5:076 may not place its proposed rates into effect until the Commission approves those rates or six months from the date of the filing of its application.

IT IS THEREFORE ORDERED that:

- 1. The procedural schedule set forth in Appendix A to this Order shall be followed.
- 2. On or before the date set forth in the procedural schedule, Peaks Mill District shall file its responses to the Commission Staff's request for information, attached to this Order as Appendix B.
- 3. Peaks Mill District shall respond to any additional requests for information propounded by Commission Staff as provided in those requests.
- 4. No later than the date set forth in the procedural schedule, Commission Staff shall file with the Commission and serve upon all parties of record a written report (Commission Staff's Report) containing its recommendations regarding Peaks Mill District's requested rate adjustment.
- 5. No later than 14 days after the date of service of the Commission Staff's Report, each party of record shall file with the Commission:
- a. Its written comments on and any objections to the findings contained in the Commission Staff's Report; and
 - b. Any additional evidence for the Commission to consider.
- 6. If Commission Staff recommends that Peaks Mill District's financial condition supports a higher rate than Peaks Mill District proposes or the assessment of an additional rate or charge not proposed in Peaks Mill District's application, Peaks Mill District in its response to the Commission Staff's Report shall also state its position in writing on whether the Commission should authorize the assessment of the higher rate or the additional rate or charge.

- 7. If Commission Staff recommends that changes should be made to the manner in which Peaks Mill District accounts for the depreciation of Peaks Mill District's assets, Peaks Mill District in its response to the Commission Staff's Report shall also state its position in writing on whether the Commission should require Peaks Mill District to implement the proposed change for accounting purposes.
- 8. A party's failure to file written objections to a recommendation contained in the Commission Staff's Report within 14 days after the date of the filing of the Commission Staff's Report shall be deemed a waiver of all objections to that finding.
- 9. If a party requests a hearing or informal conference, then the party shall make the request in its written comments and state the reason a hearing or informal conference is necessary.
- 10. A party's failure to request a hearing or informal conference in the party's written response shall be deemed a waiver of all rights to a hearing on the application and a request that the case stand submitted for decision.
- 11. A party's failure to file a written response within 14 days after the date of service of the Commission Staff's Report shall be deemed a waiver of all rights to a hearing on the application.
- 12. As set forth in 807 KAR 5:001, Section 4(11)(a), a person requesting permissive intervention in a Commission proceeding is required to demonstrate either (1) a special interest in the proceeding that is not adequately represented in the case, or (2) that the person requesting permissive intervention is likely to present issues or develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. Therefore, any person requesting to

intervene in a Commission proceeding must state with specificity the person's special interest that is not otherwise adequately represented or the issues and facts the person will present that will assist the Commission in fully considering the matter. A mere recitation of the quantity of the utility consumed by the movant or a general statement regarding a potential impact of possible modification of rates will not be deemed sufficient to establish a special interest.

- 13. Any motion to intervene filed after the date established in the procedural schedule attached as Appendix A to this Order shall also show good cause for being untimely. If the untimely motion is granted, the movant shall accept and abide by the existing procedural schedule.
- 14. The Commission directs the parties to the Commission's July 22, 2021 Order in Case No. 2020-00085³ regarding filings with the Commission.

COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION TO PEAKS MILL WATER DISTRICT

Peaks Mill Water District (Peaks Mill District), pursuant to 807 KAR 5:001, shall file with the Commission an electronic version of the following information. The information requested is due on January 22, 2024. The Commission directs Peaks Mill District to the Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Peaks Mill District shall make timely amendment to any prior response if Peaks Mill District obtains information that indicates the response was incorrect or incomplete

when made or, though correct or complete when made, is now incorrect or incomplete in

any material respect.

For any request to which Peaks Mill District fails or refuses to furnish all or part of

the requested information, Peaks Mill District shall provide a written explanation of the

specific grounds for its failure to respond completely and precisely.

Careful attention shall be given to copied and scanned material to ensure that it is

legible. When the requested information has been previously provided in this proceeding

in the requested format, reference may be made to the specific location of that information

in responding to this request. When applicable, the requested information shall be

separately provided for total company operations and jurisdictional operations. When

filing a paper containing personal information, Peaks Mill District shall, in accordance with

807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information

cannot be read.

1. Provide copies of each of the following, and when appropriate, provide in

Excel spreadsheet format with all formulas, rows, and columns unprotected and fully

accessible:

a. The general ledger and the trial balance for the calendar year 2022

and 2023.

b. Adjusted trial balance showing unaudited account balances, audit

adjustments, and audited balances for the calendar year 2022 and 2023.

C. Provide a reconciliation of the general ledger to the Schedule of

Adjusted Operations if more than one general ledger account is included in an operating

expense category (e.g., three general ledger accounts make up Contractual Services – Other; or, 5 general ledger accounts make up Miscellaneous Expenses).

- d. Minutes from Peaks Mill District's commissioner meetings for the calendar years 2022 and 2023.
- e. Copies of property, automotive and liability insurance invoices, and coverage declarations for 2022 and 2023.
- f. A document listing the job titles, job description, test year hours worked, test year pay rates, hire dates, termination dates, FICA withholding (both Social Security and Medicare tax), and total amounts paid for each employee during 2022. Designate positions by number (i.e., Position 1, position 2, etc.) and title, and do not provide employee names.
 - g. State whether each employee is full or part-time.
- h. Minutes from Peaks Mill District's commissioner meetings, authorizing current salaries and wage rates for all current employees.
- i. A list that describes all employee benefits, other than salaries and wages, paid to, or on behalf of, each employee during calendar years 2022 and 2023.
 Include the required employee contribution percentage for each benefit.
- j. A document listing the name of all commissioners for the years 2022 and 2023, and state, individually, the total amount of each benefit paid to, or on the behalf of, each commissioner during each year (i.e., wages, health insurance premiums, life insurance premiums, FICA taxes, etc.).
- k. Fiscal Court minutes that authorize the appointment, beginning and ending of term, and annual compensation of each commissioner.

- 2. Provide a copy of the most recent invoice received for all employee benefits provided to employees.
- 3. State whether Peaks Mill District sources any purchased water from any source other than Frankfort Plant Board and, if so, provide the amount purchased in gallons (Omit 000's) and the cost for each source for the test year.
- 4. Provide the number of new water connections that Peaks Mill District installed in calendar year 2022.
- 5. Refer to Peaks Mill District's Tariff, PSC Ky. No. 2, Original Sheet No. 4, Billing, Meter Readings and Related Information, Frequency of meter reading.
 - a. Confirm the date that Peaks Mill District billing cycle begins (meter read date).
 - b. State whether the date that the billing cycle begins is the date that would be best stated as the effective date of any order the Commission issues concerning rates in this case.
- 6. State the last time Peaks Mill District performed a cost-of-service study (COSS) to review the appropriateness of its current rates and rate design.
- a. Explain whether Peaks Mill District considered filing a COSS with the current rate application and the reasoning for not filing one.
- b. Explain whether any material changes to Peaks Mill District system would cause a new COSS to be prepared since the last time it completed one.
- c. If there have been no material changes to Peaks Mill District system, explain when Peaks Mill District anticipates completing a new COSS.

- d. Provide a copy of the most recent COSS that has been performed for Peaks Mill District system in Excel spreadsheet format with all formulas, rows, and columns fully accessible and unprotected.
- 7. Refer to the Application, Attachment 4, the Schedule of Adjusted Operations.
- a. Refer to reference J which reflects an increase of \$9,235 to Miscellaneous Service Revenue for the customer fee charged to Elkhorn Water District.

 Describe the scope of services provided to Elkhorn Water District.
- b. Describe Contractual Services Other, including provider name, type of service provided, rates, and calculations to support each pro forma amount that is included in the total pro forma amount of \$264,948.
- c. Explain reference M which reflects a decrease of \$96,120 to purchased water expense based on reduced leakage. Describe the basis for the adjustment in detail and provide supporting calculations. Also state whether the reduction is due to water loss efforts that have already occurred and been proven or whether the adjustment is for projected reduced water loss.
- d. Explain reference N which reflects a decrease of \$10,142 to purchased water expense based on lower rate from Frankfort for flushed water. Provide calculations for this adjustment and describe the basis for this decision in detail.
- 8. Provide a schedule listing the number of occurrences for each nonrecurring charge that was recorded during the test year, the total amount recorded, and the general ledger accounts where amounts were recorded for each nonrecurring charge. If the revenue for any nonrecurring charge was zero, include that charge and indicate that no

revenue was recorded. Include the general ledger account numbers where each nonrecurring charge is recorded.

- 9. Provide updated cost justification sheets to support each nonrecurring charge listed in Peaks Mill District's tariff.
- 10. Provide updated cost justification sheets to support each Meter Connection/Tap-on Charge listed in Peaks Mill District's tariff.
