ORDER

On January 17, 2024, the Commission issued a final Order in this matter. The Order contained an incorrect date in ordering paragraph 6. The Order also lacked clarifying language in findings paragraph 6 and ordering paragraph 6.

Finding that the January 17, 2024 Order should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. The date at the end of ordering paragraph 6 is stricken and is replaced with the following language:

December 31, 2024.

2. In findings paragraph 6, page 6, following the clause “based on projected 2024 results” the following parenthetical is added for clarity:

(year-to-date October 2024 plus projected November and December 2024).

3. In ordering paragraph 6, page 7, following the clause “based on projected 2024 results” the following parenthetical is added for clarity:

(year-to-date October 2024 plus projected November and December 2024).

4. All other provisions of the Commission's January 17, 2024 Order that are not in conflict with the terms of this Order shall remain in effect.
