ORDER

On January 5, 2024, the Commission issued an Order in this matter approving the 2023 Water Personnel Training Seminar conducted by the Commission on December 5 and 6, 2023, for six credit hours of water district management training and six hours of new water district commissioner training per day. 4. This case is closed and removed from the Commission's docket.


