ORDER

This matter arises upon the motion of the Kentucky Industrial Utility Customers, Inc. (KIUC), filed January 8, 2024, for full intervention. As a basis for its motion, KIUC stated that as an association of the largest electric and gas public utility customers in Kentucky, its interest cannot be adequately represented by an existing party.

LEGAL STANDARD

The only person who has a statutory right to intervene in a Commission case is the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General), pursuant to KRS 367.150(8)(b). Intervention by all others is permissive and is within the sole discretion of the Commission.¹

The regulatory standard for permissive intervention, set forth in 807 KAR 5:001, Section 4, is twofold. Commission regulation 807 KAR 5:001, Section 4(11), requires a person to set forth in the motion to intervene either (1) a special interest in the proceeding that is not otherwise adequately represented in the case, or (2) that intervention is likely

to present issues or develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings.

DISCUSSION AND FINDINGS

Based on a review of the pleadings at issue and being otherwise sufficient advised, the Commission finds that KIUC has demonstrated that it has a special interest in the proceeding over which the Commission has jurisdiction that is not otherwise adequately represented or that KIUC is likely to present issues or develop facts that will assist the Commission in considering this matter without unduly complication the proceedings, for the reasons discussed below.

KIUC argued that its members are large industrial customers who take service from Louisville Gas and Electric Company (LG&E) and Kentucky Utilities Company (KU) (jointly, LG&E/KU) on a different rate schedule than residential customers. KIUC also argued that "reliability is especially important to modern manufacturing processes that heavily rely on computer automation." Additionally, KIUC stated that the Attorney General's statutory obligation is to represent the interests of those residential customers, not industrial customers.

KIUC also asserted that it can present issues and develop facts which "will assist the Commission in fully considering the matters at hand." In support of its argument, KIUC noted its long history as an active participant at the Commission, having intervened in many cases addressing electric rate and service issues. KIUC stated that it will be an active participant in this case and that it will assist in developing facts that will assist the

Commission. The Commission agrees, that based on past practice, and KIUC's statements in this case, KIUC will present issues and develop facts related to this case that supports granting KIUC intervention.

Based on the above, the Commission finds that KIUC should be granted full rights of a party in this proceeding. The Commission directs KIUC to the Commission's July 22, 2021, Order in Case No. 2020-00085⁴ regarding filings with the Commission.

IT IS HEREBY ORDERED that:

- 1. KIUC's motion to intervene is granted.
- 2. KIUC is entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.
- 3. KIUC shall comply with all provisions of the Commission's regulations, 807 KAR 5:001, Section 8, related to the service and electronic filing of documents.
- 4. KIUC shall adhere to the procedural schedule set forth in the Commission's December 22, 2023 Order and as amended by subsequent Orders.
- 5. Pursuant to 807 KAR 5:001, Section 8(9), within seven days of service of this Order, KIUC shall file a written statement with the Commission that:
- a. Certifies that it, or its agent, possesses the facilities to receive electronic transmissions; and
- b. Sets forth the electronic mail address to which all electronic notices and messages related to this proceeding shall be served.
