ORDER

On April 12, 2024, the Commission entered a procedural schedule in the above-styled matter. On May 2, 2024, a hearing was held regarding Morgan County Water District’s (Morgan District) motion for emergency interim rate relief.¹ At the conclusion of testimony, the Commission, on its own motion, found that the procedural schedule entered on April 12, 2024, should be amended. The Commission also finds that an additional request for information is needed for Commission Staff to adequately review Morgan District’s application for an alternative rate adjustment.

IT IS THEREFORE ORDERED that:

1. The procedural schedule issued on April 12, 2024 shall be amended.
2. The procedural deadlines set forth in the Appendix to the Order dated April 12, 2024, starting with the date for “[a]ll Intervenor requests for information to Morgan District shall be filed no later than” shall be stricken and replaced with the procedural schedule attached to this Order as an Appendix.
3. The procedural schedule set forth in the Appendix to this Order shall be followed.

4. All other provisions of the April 12, 2024 Order not in conflict with this Order, shall remain in full force and effect.


