ORDER

On February 28, 2025, the Commission issued an Order in this case, which inadvertently failed to address Schedule L-Large Commercial and Industrial in Appendix B.¹ Jackson Purchase Energy Corporation (Jackson Purchase Energy) listed Schedule L in its application, although the application did not indicate any customers are receiving service pursuant to Schedule L.²

Finding that the February 28, 2025 Order should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. Appendix B of the February 28, 2025 Order is amended to include the following language:

Large Commercial and Industrial

Customer Charge	\$424.97 per month
Energy Charge	\$0.048000 per kWh
