The Commission Staff has reviewed the application in the above case. This filing is rejected for the reasons set forth below.

Filing deficiencies pursuant to:

1. 807 KAR 5:001 Section 14(3): The application should be amended to include current (2024) certificate of good standing for the state of Organization and a current certification of authorization from the Commonwealth of Kentucky.
2. 807 KAR 5:063, Section 1(1)(g): Requires the identity and qualifications of each person directly responsible for the design and construction of the proposed tower.
3. 807 KAR 5:063, Section 1(1)(k): Requires a map drawn to a scale no less than 1-inch equals 200 ft, that identifies every structure and every owner of real estate within 500 ft of the proposed tower.
4. 807 KAR 5:063, Section 1(2)(a): Requires a copy of the language on the signs required by the regulation, including the word "monopole" or "tower" printed at least four (4) inches high.
5. 807 KAR 5:063, Section 1(2)(a): Requires A map of the area in which the tower is proposed to be located, that is drawn to scale and that clearly depicts the search area in which a site should, pursuant to radio frequency requirements, be located.

You are requested to submit the information necessary to cure the deficiencies within 10 days of the date of this letter. If you need further assistance, please contact my staff at 502-564-3940.
