The Commission Staff has reviewed the application in the above case. This filing is rejected for the reasons set forth below.

Filing deficiencies pursuant to:

1. 807 KAR 5:001 Section 14(3): The application, page 2 at 3, states AT&T Mobility is a limited liability company organized in the State of Delaware on October 20, 1994, and AT&T Mobility's certificate of good standing issued by the State of Delaware is attached as part of Exhibit A. However, the corporate documentation in Exhibit A is for New Cingular Wireless. The applicant needs to provide the additional certificates of organization and good standing for AT&T or explain the discrepancy.
2. 807 KAR 5:063 Section 1(1)(b): The application, page 4 at 12, states documentation confirming that notice of the proposed construction to the Federal Aviation Administration ("FAA") is not required. The regulation calls for an application. The applicant needs to provide an official application, and/or an official certificate from the FAA that documentation is not required.

You are requested to submit the information necessary to cure the deficiencies within 10 days of the date of this letter. If you need further assistance, please contact my staff at 502-564-3940.
