ORDER

Pursuant to 807 KAR 5:056, the Commission, on August 2, 2024, established this case to review and evaluate the application of the Fuel Adjustment Clause (FAC) of Jackson Purchase Energy Corporation, Kenergy Corp., and Meade County Rural Electric Cooperative Corporation (collectively, Cooperatives or individually Cooperative) for the six-month period from November 1, 2022, through April 30, 2023. These Cooperatives represent the owner-members of Big Rivers Electric Corporation (BREC).

In establishing this review, the Commission ordered each Cooperative to individually submit certain information and an affidavit attesting to its adherence to 807 KAR 5:056.

In Case No. 2024-00141,<sup>1</sup> the Commission found that BREC improperly calculated the Fuel Adjustment Charge to the Cooperatives.<sup>2</sup> However, having considered the evidence of record in the present proceeding and being otherwise sufficiently advised, the Commission finds during the period under review, the Cooperatives have complied in

all material respects with the provisions of 807 KAR 5:056 and that the Cooperatives have properly calculated or applied the FAC charges to their retail customers.


IT IS THEREFORE ORDERED that:

1. The charges and credits applied by each individual Cooperative through the FAC for the period from November 1, 2022, through April 30, 2023, are approved.
2. This case is closed and removed from the Commission's docket.
