ORDER

On June 27, 2024, Duke Energy Kentucky, Inc. (Duke Kentucky) filed an application for a Certificate of Public Convenience and Necessity (CPCN) for a 138-kV transmission line and associated facilities. The Commission established a procedural schedule in this case by Order dated July 25, 2024. The date for all supplemental requests to be submitted to Duke Kentucky was September 6, 2024.

After reviewing the evidence in the record, on its own motion, the Commission finds that the July 25, 2024 procedural schedule should be amended to allow supplemental data requests to be submitted to Duke Kentucky by September 19, 2024. Duke Kentucky will have until September 26, 2024, to respond. All other deadlines shall remain in effect.

IT IS THEREFORE ORDERED that:

1. The Commission's July 25, 2024 procedural schedule is amended to permit issuance of Commission Staff's Second Request for Information by September 19, 2024.

- 2. The Commission's July 25, 2024 procedural schedule is amended to permit Duke Kentucky to respond to Commission Staff's Second Request for Information by September 26, 2024.
 - 3. All other terms of the Commission's July 25, 2024 Order remain in effect.
