Pursuant to a Staff Notice issued on February 3, 2025, an informal conference (IC) was conducted on February 12, 2025. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss the requirements of the Qualified Infrastructure Improvement Plan (QIIP) with Rattlesnake Ridge Water District (Rattlesnake Ridge District). Rattlesnake Ridge District advised that it had provided a one-page list of infrastructure plans for the district with its monthly surcharge reports filed on February 11, 2025. Commission Staff reviewed the submitted list with Rattlesnake Ridge District and provided some additional information that would be required in a proposed QIIP. Staff provided some improvement plan examples that might be helpful for Rattlesnake Ridge District to expand on its list of infrastructure improvement plans, and to specify what plans are directly related to unaccounted-for water loss reduction efforts. Rattlesnake Ridge District stated it would continue to work on its QIIP and file it with the Commission as soon as possible.
