RE: Informal Conference of December 18, 2024

Pursuant to a Staff Notice issued on December 11, 2024, an informal conference (IC) was conducted on December 18, 2024. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss the water loss surcharge monitoring case requirements. In particular, Peaks Mill Water District (Peaks Mill District) wanted to make sure it was filing the appropriate forms and information in its monthly filings. Staff informed the district that its most recent monthly filing contained the correct information.

Peaks Mill District's contracted engineer utilized to address water loss attended and asked several questions about the Qualified Infrastructure Improvement Plan (QIIP) and the expectations for the information contained therein. Staff explained, that although they could not speak for the Commission, the QIIP was the basis for requests for usage of the water loss surcharge funds. Staff encouraged the district to develop a comprehensive plan and include detailed information about cost and how the district prioritized the projects outlined in the plan.

Staff also mentioned that the surcharge funds were supposed to be disbursed initially prior to the purchase or expenditure of general funds to cover any water loss reduction associated expenses. However, Staff did note that this was the general rule but as noted, we could not speak for the Commission and under some circumstances, the Commission has approved reimbursement of expenses from the surcharge funds.

Staff encouraged Peaks Mill District to reach out should it have any issues going forward or any questions related to its filings.

There being no further discussion, the IC was then adjourned.
