ORDER

On April 2, 2025, Kentucky Municipal Energy Agency (Kentucky Municipal Energy) received a construction certificate to construct an approximately 75-megawatt (MW) merchant solar electric generation facility in Madisonville, Kentucky. On May 5, 2025, Kentucky Municipal Energy filed a notice of filing that included the Final Site Plan.<sup>1</sup> Kentucky Municipal Energy explained that the site plan indicates minor deviations from the preliminary site plan.<sup>2</sup> Such deviations include expanding the warehouse for additional storage, road arrangement reworked per traffic study, added 150'x60' stone yard for gas conditioning equipment, adding a pond based on local and state code, the final switchyard was updated with purchased equipment dimensions, and the tank containment was moved to 200' to the east of the stacks due to the expansion of the warehouse.

Based upon the motion, and otherwise being sufficiently advised, the Siting Board finds Kentucky Municipal Energy's final site plan should be approved. The changes between the preliminary site plan reviewed by the Siting Board during the original consideration of the case and the revised final site plan do not create a materially different pattern or magnitude of impacts.

IT IS THEREFORE ORDERED that:

1. Kentucky Municipal Energy's final site plan is approved.
2. The revised final site plan is attached as an Appendix to this Order.


