I told him that he told me I had an under ground water pipe leak. He said "II a licensed plumber had done the work, you would have paid alot more than \$300 and I suid you and Mr. Bryant said you were alicensed plumber. I attached the text correspondence after we hung up from Mr. Marcey and I.

I told him it wasn't about him, it was about what they did uf the water unethrally. Shown said it has nothing to do with the water company and I said "yes it does because yMr. Marios is your employer and the one who said I had a leak and ho said "he is not an employed he is a contractor" I informed him, that it is the same thing-He said that is between you all if he was Stealing water from us I would be upset

and do something, but I suggest you got a "bib lock for you new spigot and then he hang up the phone.

Thous not had hardly any water pressure since this. My hathroom sink upstairs harely drips out a few drips of water when handles are turned to the max. My showers used to be high pressure prior to Mr. Mar idissing in the ground and now they have extremely low pressure and the should and sink in the down stairs drip constantly. Immediately, the very next week, water camp up through the shower and over flowed into my both round and Kitchen.

I live by myself and was raiely home and my water bill was usually 90, 95, 100 per month and it wasn't until after no one would help me, I eventually was able to cut the water huses on my property, he had hidder that my bill went down to \$25 a month

Mr. Marrer never one time stepped in my house I turn the water off as Mr. Bry ant Stated tur days earlier he would be doing when he arrived


