ORDER

Garrard County Water Association, Inc. (Garrard County Water) is hereby notified that it has been named as a Defendant in a formal complaint filed on September 9, 2024, a copy of which is attached as an Appendix to this Order and incorporated herein. Sandy Morrow alleged in her complaint that an employee of Garrard County Water, in concert with her neighbor, engaged in fraudulent conduct that caused here to waste money on unnecessary plumbing work that adversely affected her water service and resulted in low water pressure. She claimed that the employee, acting as meter reader for Garrard County Water, was unqualified and used his position as meter reader to set up the alleged fraudulent scheme, and, that when she reported the incident, the utility manager acted unreasonably in responding to her complaint.

LEGAL STANDARDS

The Commission has jurisdiction pursuant to KRS 278.260 over complaints as to rates or services of any utility. 807 KAR 5:001, Section 20(1)(c), requires a complaint to

state "[f]ully, clearly, and with reasonable certainty, the act or omission" that the complaint alleges the utility failed to comply with and facts, with details, of the alleged failure. In accordance with 807 KAR 5:001, Section 20(4)(a), the Commission examines a complaint to determine whether the complaint establishes a *prima facie* case and conforms to the administrative regulation. A complaint establishes a *prima facie* case when, on its face, it states sufficient allegations that, if uncontradicted by other evidence, would entitle the complainant to the requested relief.

If a complaint establishes a *prima facie* case and conforms to the administrative regulation, 807 KAR 5:001, Section 20(4)(b), provides that the Commission shall serve an order upon the person complained of and require that the matter complained of be satisfied, or that the complaint be answered in writing within ten days from the date of service of the order.

If a complaint fails to establish a *prima facie* case or conform to the administrative regulation, 807 KAR 5:001, Section 20(4)(a)(1), provides that the complainant be notified and provided an opportunity to amend the complaint within a specified time. Additionally, 807 KAR 5:001, Section 20(4)(a)(2), provides that if the complaint is not amended within the time that the Commission grants, then the complaint shall be dismissed

DISCUSSION AND FINDINGS

Most of Ms. Morrow's claims are based on the alleged conduct and deceit of her neighbor and the utility employee acting in his private capacity as plumbing contractor. The Commission finds that Ms. Morrow should be notified that the allegations that specifically relate to her neighbor and the utility employee acting in his private capacity, as presented do not establish a *prima facie* case against the utility. The Commission

finds that Ms. Morrow should be afforded an opportunity to amend the complaint within ten days of the date of this order.

The Commission further finds that Ms. Morrow's complaint regarding the conduct of the employee, acting as meter reader, and of the utility manager, and regarding the alleged low water pressure does comply with procedural requirements and establishes a *prima facia* case against Garrard County Water. The Commission finds that pursuant to 807 KAR 5:001, Section 20, Garrard County Water should satisfy these claims or file a written answer to the complaint within ten days from the date of service of this Order. The Commission directs Garrard County Water to the Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission.

IT IS THEREFORE ORDERED that:

- 1. Garrard County Water shall satisfy the claims regarding the conduct of the district employee, acting as meter reader, and of the utility manager, and regarding the alleged low water pressure or file a written answer to the complaint within ten days from the date of service of this Order.
- 2. Sandy Morrow shall have ten days from the date of service of this Order to amend her claims regarding the alleged conduct and deceit of her neighbor and the utility employee acting in his private capacity as plumbing contractor. Any amendment shall show why Garrard County Water is responsible for the act of her neighbor and the utility employee acting in his private capacity as plumbing contractor.

3. If Sandy Morrow does not amend her complaint within the time allowed to show why the district should be held responsible for the conduct of her neighbor and the utility employee acting in his private capacity as plumbing contractor, these claims shall be dismissed.

4. A copy of this Order shall be served by U.S. mail, via certified mail with return receipt requested, on Sandy Morrow at 1274 Bryants Camp Road, Lancaster, KY 40444.





