ORDER

This matter arises upon the motion of the Western Pulaski County District (Western Pulaski District) filed June 8, 2026, to request a 45-day extension to submit its Alternative Rate Filing (ARF) Application pursuant to 807 KAR 5:076 due on July 31, 2026. Western Pulaski District explained that it has engaged Kentucky Rural Water Association (KRWA) to prepare the necessary rate study to support its ARF application. Additionally, Western Pulaski District stated that its 2025 audit has not been completed and the district filed the 2025 Annual Report on June 4, 2026, after being granted an extension to file the report after March 31, 2026. Western Pulaski District argued that the delay to finalize its 2025 annual report and time needed to complete its audit requires an extension to allow KRWA sufficient time to complete the rate study and application. Upon review of the request, the Commission finds good cause to grant Western Pulaski District's request.

IT IS THEREFORE ORDERED that:

1. The motion of Western Pulaski District is granted.

2. Western Pulaski District shall file for an alternative rate filing no later than September 15, 2026.
