ORDER

The Commission, on its own motion, HEREBY ORDERS that:

1. A hearing in this matter shall be held on May 21, 2025, at 9 a.m. Eastern Daylight Time, and continuing until called from the bench by the presiding officer, at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.
2. Pursuant to 807 KAR 5:001, Section 2, if the hearing is not concluded on the designated day, the hearing may be continued upon verbal announcement by the presiding officer. A verbal announcement made by the presiding officer shall be proper notice of the continued hearing.
3. Witnesses who sponsor schedules, testimony, or responses to requests for information shall participate in person at the May 21, 2025 hearing. Motions to excuse a witness from testifying at a Commission hearing, to substitute another witness through the adoption of testimony, or from testifying in person at a Commission hearing shall be made in writing and will be granted only upon a showing of good cause.

4. Duke Energy Kentucky, Inc. (Duke Kentucky) shall file a witness list at least seven days prior to the hearing date.

5. If a witness sponsoring testimony will be unavailable for the hearing and another party wishes to adopt the testimony, the party will need to request leave in writing to substitute or replace the original witness, including identification of the information to be adopted, no less than 14 days prior to the scheduled hearing date.

6. Duke Kentucky shall give notice of the hearing in compliance with 807 KAR 5:001, Section 9(2)(b). In addition, the notice of hearing shall include the following statements: "This hearing will be streamed live and may be viewed on the PSC website, psc.ky.gov" and "Public comments may be made at the beginning of the hearing. Those wishing to make oral public comments may do so by following the instructions listed on the PSC website, psc.ky.gov." At the time the notice is mailed, or publication is requested, Duke Kentucky shall forward a duplicate of the notice and request to the Commission.

7. Pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9), a digital video transcript shall be made of the hearing.
