## PSC Response Request

In response to the filing of Woods Creek Water District:

The City of Livingston has issued payment for water bills prior to the due date. The City of Livingston had already issued a payment for the water bill due in March on March 13<sup>th</sup>, 2025, which was deposited on March 28<sup>th</sup>, 2025 by Woods Creek Water District.

*“The Commission finds that to assure adequate, efficient, and reasonable service between Wood Creek District and Livingston, Wood Creek District should not terminate water service to Livingston so long as Livingston is making a monthly payment addressing all or portions of Livingston’s most recently billed water purchase and portions of the accrued arrearage, or upon order of the Commission.”* (Paragraph 3, sentence 1 of PSC order)

Livingston Municipal Water Works has not failed to make a monthly payment addressing all of Livingston’s most recently billed water purchases, and as the order states, Livingston Municipal Water Works could make portions for the most recently billed water purchase. However, that has not occurred. The Public Service Commission has also not ordered the water service to be disconnected as stated in the last section of the statement quoted above. Livingston Municipal



Water Works is willing to hand-deliver future payments to avoid future discrepancies or arguments on the date of receipt or arrival of payments, for the discretion of accrued late charges. Livingston is willing to pay the amount of \$1,173.42 in claimed late fees by Woods Creek Water District if necessary to avoid a cut-off for the customers of Livingston Municipal Water Works and Kentucky American Water Customers. However, we do not feel that the fees are owed or that the notice of cut-off has been appropriately issued according to the order given by the Public Service Commission.
