ORDER

On February 13, 2025, Appalachian Citizens' Law Center, Kentuckians for the Commonwealth, and Mountain Association, (collectively, Joint Intervenors) moved the Commission to admit *pro hac vice* Shannon Fisk, an attorney whose office is in New York, to practice law before the Commission on behalf of the Joint Intervenors in association with Byron L. Gary, an attorney licensed to practice law in the Commonwealth of Kentucky, in this case. IT IS THEREFORE ORDERED that Shannon Fisk is admitted *pro hac vice* for the purpose of representing the Joint Intervenors in association with Byron L. Gary in the above-styled proceeding, provided that Byron L. Gary or another member of the Kentucky

Bar Association acts as co-counsel and is present at all proceedings before this Commission.
