The attachment appears to contain a routine applicant's NOTICE letter requesting ad hoc appointment for Owensboro Solar, LLC. Upon further review and Investigaton, I discovered false information in the submittal. Specifically, on Page 2, Paragraph 3. The cited address is false. I have confirmed by checking with the Authoritative Source who has exclusive authority to assign property address for Daviess County. The staff person confirmed there is "no address point" for the cited location. Additionally, the lat./long. coordinates location determination reflect the address point if on a separate property tract that is not reported to be under the solar company's jurisdiction.
