ORDER

On May 20, 2025, Navitas KY, LLC (Navitas KY) requested a hearing in this matter, noting that the Commission's procedural schedule issued February 3, 2025, provided a May 19, 2025 deadline to request a hearing. Navitas KY's attorney indicated that its hearing request was "made several minutes into the 20th of May, as the undersigned experienced technical issues impeding its earlier submission" and asked for the Commission "[t]o the extent necessary, please consider this submission as a motion to briefly extend the deadline for filing" due to excusable neglect.

The Commission finds that extension of the deadline should be granted due to excusable neglect, the de minimis delay of the filing, and the lack of intervenors to this proceeding to be prejudiced by the late filing. Furthermore, the Commission finds that Navitas is entitled to a hearing pursuant to KRS 278.260(1).

IT IS THEREFORE ORDERED that:

1. Navitas KY's motion for an extension of time for requesting hearing and Navitas KY's request for a hearing are granted.

- 2. A hearing in this matter shall be held on August 12, 2025, at 9 a.m. Eastern Daylight Time and continuing until called from the bench by the presiding officer, in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.
- 3. Pursuant to 807 KAR 5:001, Section 2, if the hearing is not concluded on the designated day, the hearing may be continued upon verbal announcement by the presiding officer. A verbal announcement made by the presiding officer shall be proper notice of the continued hearing.
- 4. Witnesses who sponsored schedules, testimony, or responses to requests for information shall participate in person at the August 12, 2025 hearing.
- 5. Navitas KY shall give notice of the hearing to all customers in compliance with 807 KAR 5:001, Section 9(2)(b). In addition, the notice of hearing shall include the following statements: "This hearing will be streamed live and may be viewed on the PSC website, psc.ky.gov" and "Public comments may be made at the beginning of the hearing. Those wishing to make oral public comments may do so by following the instructions listed on the PSC website, psc.ky.gov." At the time the notice is mailed or publication is requested, Navitas KY shall forward a duplicate of the notice and request to the Commission.
- 6. Pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9), a digital video transcript shall be made of the hearing.
