ORDER

On February 28, 2025, the Commission issued an Order in this matter approving Columbia Gas of Kentucky's Gas Cost Adjustment (GCA) rates for billing with the final meter readings beginning on and after February 28, 2025. This Order contained a scrivener's error in the rate Appendix attached to the Order.

Finding that the February 28, 2025 Order should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. The following is stricken from page 2 of the rate Order under the heading "Discussion", second sentence, contained in lines 3-5:

Columbia Kentucky's report sets out an Expected Gas Cost (EGC) of \$6.2412 per Mcf, which is an increase of \$0.7237 per Mcf from its previous EGC of \$5.175 per Mcf.

And replaced with the following language:

Columbia Kentucky's report sets out an Expected Gas Cost (EGC) of \$6.2412 per Mcf, which is an increase of \$0.7237 per Mcf from its previous EGC of \$5.5175 per Mcf.

2. The following is stricken from page 1 and 2 of the rate Appendix under footnote reference 4:

The Gas Cost Adjustment, as shown, is an adjustment per Mcf determined in accordance with the "Gas Cost Adjustment Clause" as set forth on Sheets 48 through 51

of Columbia Kentucky's Tariff. The Gas Cost Adjustment applicable to a customer who is receiving service under Rate Schedule GS or IUS and received service under Rate Schedule SVGTS shall be \$5.5175 per Mcf only for those months of the prior 12 months during which they were served under Rate Schedule SVGTS.

And replaced with the following language:

The Gas Cost Adjustment, as shown, is an adjustment per Mcf determined in accordance with the "Gas Cost Adjustment Clause" as set forth on Sheets 48 through 51 of Columbia Kentucky's Tariff. The Gas Cost Adjustment applicable to a customer who is receiving service under Rate Schedule GS or IUS and received service under Rate Schedule SVGTS shall be \$6.2412 per Mcf only for those months of the prior 12 months during which they were served under Rate Schedule SVGTS.

3. All other provisions of the Commission's February 28, 2025 Order that are not in conflict with the terms of this Order shall remain in effect
