**RE:** Informal Conference of August 18, 2025

Pursuant to Commission Staff's Notice issued on August 5, 2025, an Informal Conference (IC) was conducted on August 18, 2025. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss possible resolutions regarding the complaint filed by Larry and Debra Peterman against Kentucky Power Company (Kentucky Power) on December 6, 2025, concerning the stray voltage in and around the Petermans' pool.

Kentucky Power reiterated the scope of testing that had been performed during the three on-site visits to the Petermans' house in September and November of 2024, and added more detail describing the specific testing conducted. Mr. and Mrs. Peterman asked pointed questions for an explanation as to how their hired master electrician came to a different conclusion than the Kentucky Power electricians and engineer.

Both sides agreed that there was a disconnect between the Petermans and Kentucky Power concerning exactly what tests had been conducted and the final interpretation of those results.

Kentucky Power stated that they were concerned with the situation and would be willing to go back to the Petermans residence at a time convenient for the Petermans master electrician to be present. The parties agreed to schedule the next on-site visit between themselves and would notify PSC staff when it is to occur.

There being no further discussion, the IC was then adjourned.
