DECLARATORY ORDER ON FREE GAS

REQUEST FOR INTERVENTION OF KATHY HOWARD

Comes now Kathy Howard and requests an Order of the Kentucky Public Service Commission allowing her to intervene in the above styled case and as grounds for said Motion, states that she is entitled to free gas from Kentucky Frontier, LLC as the pipeline in question, the Fontaine-Williams gas gathering system pipeline traverses her property. Kathy Howard's mother, Pauline Howard, executed a right of way easement agreement to BTU Gas Company and was granted free gas use for residential dwellings on the property which she now inhabits. The BTU Gas Company right of way easement agreement is unrecorded.

The action sought by Kentucky Frontier Gas, LLC would terminate her right to free gas which was a consideration for the right of way for the Fontaine-Williams gas gathering system pipeline. The Fontaine-Williams gas gathering system pipeline will continue to exist on her property but she will no longer receive the agreed to compensation for such pipeline as was set out in the right of way easement agreement executed by Pauline Howard. A copy of the Deed to Kathy Howard is attached as Exhibit A.

WHEREFORE, Kathy Howard requests an Order of the Kentucky Public Service Commission allowing her to intervene in the above styled action for the reasons set forth above.

WITNESSETH: That said Party of the First Part for and in consideration of the love and affection she has for her daughter, Grantee, the receipt of which is hereby acknowledged, do hereby grant and convey to Party of the Second Part, her heirs and assigns, the following described property in Magoffin County, Kentucky, to-wit:

The following described tract or parcel of land, lying and being in Magoffin County, Kentucky, on the waters of Licking River, more particularly described as follows:

BEGINNING at a marked sycamore at Forrest Salyers line; thence across the highway a north course with Lot No. 4 to Jane Salyer's line; thence with center of ridge to Malcolm Joseph's line (or Farish Wireman line); thence with said line to Dovie Miller's (or Joe Miller's line); thence running with same line to a marked hickory; thence a straight line down the point to a marked white oak; thence down the hill to a marked maple; thence a straight line across the highway to a marked rock; thence up the highway to an iron stake; thence a sraight (sic) line across the highway to a marked sycamore; thence up the hill to a cherry tree; thence a straight line up the point to a marked poplar; thence a straight line up the point to Dud Carpenter's line; thence running with said line down the point across the highway and river and with same line up the hill to Glenn Salyer's line; thence with same line down the point to Forrest Salyer's line; thence with same line on down the point to the cemetery; thence around right side of cemetery to a marked corner post; thence on down the point to a marked

(All mineral and mineral rights previously reserved).

EXCEPTIONS: There is excepted and excluded from the above described property the following tracts of property:

Tract No. 1:

Beginning at the highway at "Chandler Allen's" approach at a marked sycamore stump; thence running a southeasterly direction up the point with Forrest Salyers' line to the top of the knob to Dud Carpenter's line; thence down the point to Virgie Shepherd's line; thence down the hill with said line to the highway; thence down the highway to the beginning.

Being the same property conveyed from Sammy Howard and Pauline Howard, his wife, to Lewis Miller and Madelene Miller, his wife, by deed dated August 24, 1974, recorded in Deed Book 108, Page 239, of the Magoffin County Clerk's Office.

BEGINNING at the upper side of Highway Route 7 with an iron pipe, running a southeasterly course to a marked white oak; thence a straight line to another marked white oak; thence a straight line to another marked white oak, on up the hill to a marked maple, (the calls from the beginning to the maple, make an approximate straight line), thence on up the hill to the center of the point to Dud Carpenter's line; thence down the point with said line to the highway; thence down the highway to the beginning which is an iron pipe, 20 acres more or less.

The mineral rights have been excepted.

Pauline Howard, his wife, to Virgil Shepherd and Brenda Shepherd, by deed dated January 15, 1974, recorded in Deed Book 106, Page 401, of the Magoffin County Clerk's Office.

Being the same property conveyed to Pauline Howard from Kathy Howard by deed dated April 12, 1991, recorded April 17, 1991, in Deed Book 141, Page 646, of the Magoffin County Clerk's Office.

Also, being the same property inherited by parties hereto as shown by Affidavit of Descent of Sammy Howard of record in Deed Book 141, Page 645, of the Magoffin county Clerk's Office.

To have and to hold the same, together with all the appurtenances thereunto belonging unto the Party of the Second Part, her heirs and assigns, with covenant of general warranty.


