Comments: I'm writing to ask you not to support this 25 percent increase in the cost of our water. When combined with the cost of our sewer (billed at 3x the cost of the water) it is already difficult to afford such a simple aminity as water. I've done everything I can to lower our bill. All of my appliances are water saving efficient. I work 24/hr shifts so I shower at work. My husband and children are limited to short showers. There's literally nothing left we can do to keep the cost lower. Adding a 25 percent increase to the cost is simply not acceptable. In addition to that there's so much chlorine added it usually smells like pool water. The water tastes bad enough that I had to buy a 5-gallon

dispenser and purchase the large bottles for drinking water. To think we may have to pay 25 percent more (plus 3x the water cost for sewer) is just ridiculous. Please do not approve this increase.
