ORDER

On May 12, 2025, East Kentucky Power Cooperative, Inc. (EKPC) filed a motion requesting that the Commission schedule an informal conference (IC) for the purpose of discussing Commission Staff's First Request for Information, which requests new modeling data based on a potential data center load. EKPC asserted that it seeks additional information before it obtained the services of an outside consultant for additional modeling.

Based upon the motion, the Commission finds that EKPC established good cause to schedule an IC, and therefore the motion should be granted. A remote IC is scheduled on May 28, 2025, at 10 a.m. Eastern Daylight Time. Commission Staff will contact participants by electronic mail to provide details for joining the conference by video link.
