ORDER

On April 1, 2025, East Kentucky Power Cooperative, Inc. (EKPC) filed with the Commission its 2025 Integrated Resource Plan (IRP).¹ The Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General),² and Sierra Club³ were permitted to intervene in this matter pursuant to 807 KAR 5:001.

On April 10, 2025, an Order was entered establishing a procedural schedule for the orderly review of EKPC's 2025 IRP.⁴ On July 1, 2025, an Order amending the procedural schedule was issued.⁵ The procedural schedule allowed for two rounds of requests for information to EKPC and an opportunity for intervenors to file written comments regarding the IRP. A hearing was conducted in this matter on March 10, 2026, and all parties were permitted to file post-hearing comments.

By Order issued on June 1, 2026, the Commission entered into the record of this case a report summarizing Commission Staff's review (Staff Report) of EKPC's 2025 IRP.⁶ On June 5, 2026, pursuant to a post-hearing procedural schedule, EKPC filed comments regarding the Staff Report.⁷

Based on the evidence of record and being sufficiently advised, the Commission finds that all substantive actions in this case have been completed, and this case should be closed and that EKPC's next IRP shall be filed on or before April 1, 2028.

IT IS THEREFORE ORDERED that:

1. EKPC shall file its next IRP no later than April 1, 2028.
2. This case is closed and removed from the Commission's docket.


