## ORDER

On May 30, 2025, Kentucky Utilities Company (KU), pursuant to KRS Chapter 278, filed its application for an adjustment of its electric rates and for approval of certain regulatory and accounting treatments.<sup>1</sup>

On July 31, 2025, the Commission on its own motion, provided notice to all parties that four in-person public comment meetings regarding KU's application would be held and provided specific dates and locations. This Order arises following the Commission being notified that Hopkins County officials had discovered a double-booking conflict with the meeting originally scheduled for October 13, 2025, at 5 p.m. Central Daylight Time, at the Hopkins County Fiscal Court, 56 North Main Street, Madisonville, Kentucky 42431.<sup>2</sup>

As a result of the booking conflict, the Commission, on its own motion, finds that it should reschedule the in person public comment meeting originally scheduled for October 13, 2025, at 5 p.m. Central Daylight Time, at the Hopkins County Fiscal Court, 56 North Main Street, Madisonville, Kentucky 42431. The meeting should be rescheduled

to October 30, 2025, at 5 p.m. Central Daylight Time, at the Hopkins County Fiscal Court, 56 North Main Street, Madisonville, Kentucky 42431.

The Commission further finds that a deviation, pursuant to Section 22 of 807 KAR 5:001, should be granted to KU from the publication of notice requirements of 807 KAR 5:001, Section 9(2)(b). To inform the public of the rescheduling of the public meeting, KU and the Commission Staff should immediately and prominently post notification of the rescheduling of this meeting on each organization's respective website, and PSC Staff should request that the appropriate Hopkins County governmental entity post the same.

In addition to the opportunity to provide public comments at the meeting scheduled in this Order, written public comments may be tendered to the Commission at any time during the consideration of this case. Written public comments should include your name, address, and reference Case No. 2025-00113. Written public comments may be mailed to the PSC at P.O. ## IT IS THEREFORE ORDERED that:

- 1. The in-person public meeting scheduled for October 13, 2025, at 5 p.m. Central Daylight Time, is rescheduled, and shall be held on October 30, 2025, at 5 p.m. Central Daylight Time, at the Hopkins County Fiscal Court, 56 North Main Street, Madisonville, Kentucky 42431.
- 2. KU is granted a deviation to the publication of notice requirements 807 KAR 5:001, Section 9(2)(b). To provide public notice, KU shall immediately and prominently

post notification of the rescheduling of this meeting on its website post, including the date and location of the rescheduled meeting.

3. Commission Staff shall immediately and prominently post notification of the rescheduling of this meeting on the Commission's website, including the date and location of the rescheduled meeting. Commission Staff shall also request that the appropriate Hopkins County post notification of the same.

4. All provisions of the Commission's July 31, 2025, Order that are in conflict with the provisions of this Order are vacated, and all other provisions not in conflict with the provisions of this Order shall remain in effect.
