I am submitting this comment as a residential customer of Kentucky Utilities Company. I strongly oppose any increase to the residential fixed service charge, which functions as a regressive tax on consumers.

This increase is an injustice that severely penalizes low-usage customers and eliminates the financial incentive for conservation.

- 1. **Punishing Conservation:** I intentionally live in a small, 600 sq. ft. studio apartment specifically to reduce my energy footprint. My total monthly electric bill is consistently low, typically in the \$50-\$60 range. An increase to the fixed fee will consume a massive, disproportionate percentage of my total bill, regardless of how aggressively I conserve energy (including sitting in a 55°F apartment).
- Unfair Burden on Small Dwellings/Historical Property: Charging this high fixed
 fee equally to a unit in an apartment building that has been hooked up and paid for
 since the 1940s/50s is unfair. The infrastructure costs to serve this high-density
 location have been paid over many decades, yet low-volume, high-density

customers are being forced to subsidize the high costs of infrastructure for large corporations.

I urge the Commission to reject the proposed fixed fee increase and protect low-usage customers who are responsible conservers.
