

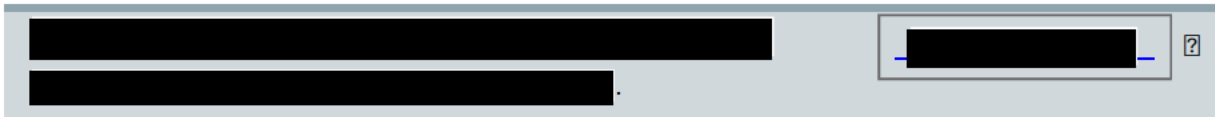

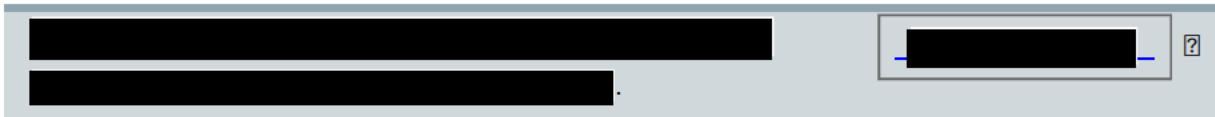

Subject: Opposition to Proposed 8.3% Electric and 14% Gas Rate Hikes – Unjust, Unfair, and Harmful to Vulnerable Communities

To Whom It May Concern,

I am writing to voice my strong objection to the proposed utility rate increases—8.3% for electricity and an alarming 14% for gas—by Louisville Gas and Electric (LG&E). These hikes are unjust, deeply unfair, and would cause disproportionate harm to the residents of our community, particularly those already struggling to make ends meet.

LG&E operates as a state-sanctioned monopoly, meaning customers have no option to seek more affordable or competitive utility services elsewhere. In this environment, raising rates so aggressively places an unreasonable burden on the public, especially low-income households, seniors on fixed incomes, and working families already living at or below the poverty line.

To put it plainly: people cannot live without heat or electricity. These are not luxuries—they are basic needs. Increasing gas rates by 14% and electric rates by 8.3% will force many in our community to make painful decisions between staying warm, feeding their families, or paying for medicine. This is not hypothetical—it is the lived reality for many of your customers.

When a monopoly is allowed to raise rates without direct competition or meaningful public accountability, it effectively holds the public hostage. That is precisely why monopolies are traditionally restricted or subject to strong regulatory scrutiny. Using a monopoly position to push through such steep increases, especially during a time of economic pressure, is not only ethically questionable—it is economically and socially harmful.

I urge LG&E and the Kentucky Public Service Commission to reject these increases. Instead, consider cost-saving reforms, more transparent public involvement, and shareholder responsibility before shifting the financial burden to those least able to bear it.

Utility companies must operate in the public interest, not just for corporate gain. Rate hikes of this scale, in a monopolized market, undermine public trust and deepen inequities in our communities.

Thank you for your attention to this critical matter. I ask that this letter be included in the public record of responses regarding the proposed rate changes.

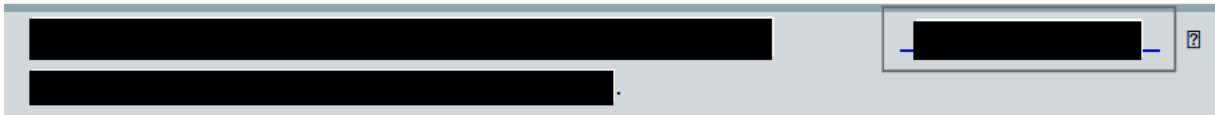

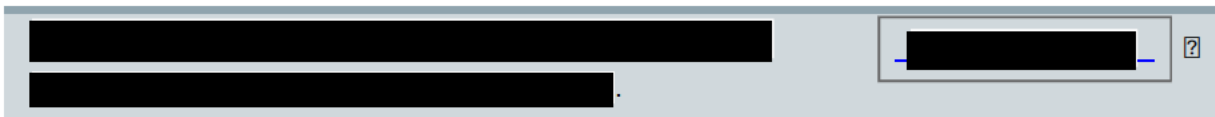

Tell them that they need to set up a 5 year project plan and explain it to all and maybe we will not think the monies are going g to the top.

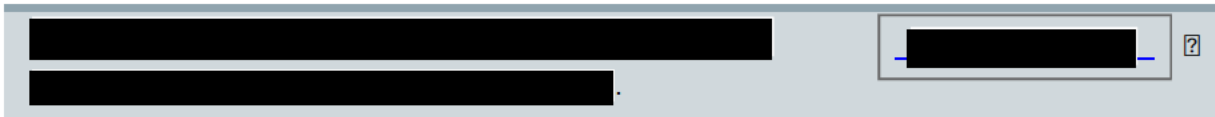

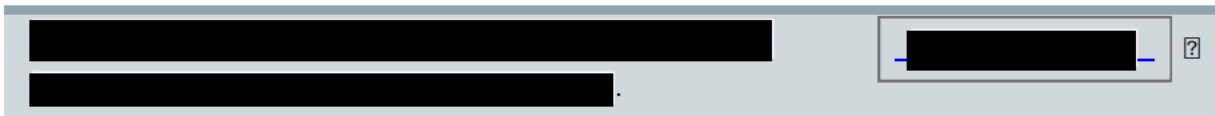

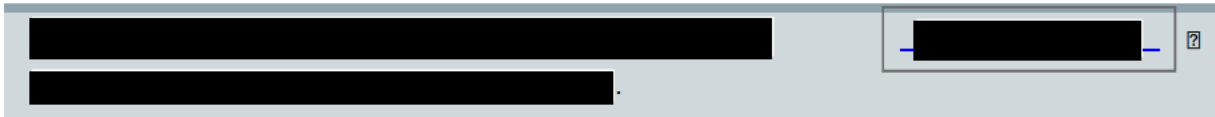
